



ACSS' Representation Program Helps Members Achieve Favorable Outcomes

ACSS' purpose is to effectively advocate for and represent its members. Our mission is to ensure that all excluded employees receive fair and equitable representation, compensation, and benefits. Each year ACSS' skilled team of Attorneys and Labor Relations Representatives (LRRs) assist members with hundreds of formal grievances and appeals. While many of these appeals and issues are favorably resolved by ACSS through settlement agreements beneficial to the members, on occasion, cases require escalation to a full evidentiary hearing. As an ACSS member, you have an advantage with ACSS on your side. If you are experiencing a difficult time in your career, ACSS is here to guide you through the process. You are not alone.

Here are some examples of how ACSS has helped members this year:

CDCR Employee Reinstated with one full year of back-pay salary

A member at the California Department of Corrections and Rehabilitation (CDCR) found that her new state position did not match what she was told when being hired and she wanted to return to her prior classification at her prior state agency. When the member made a written request to return to her old department, CDCR construed this request as a resignation from state service.

ACSS filed an appeal with the Department of Human Resources (CalHR) seeking to set aside the "resignation" and return the member to work. When a quick settlement could not be achieved, the matter proceeded to a hearing before a CalHR Administrative Law Judge. Following three days of testimony and legal briefs on the issues, the Judge issued a decision ordering the member to be reinstated with nearly one-year of back salary.

Caltrans member retires with lump sum instead of dismissal

A member at the Department of Transportation was served a dismissal. Although the member disagreed with the dismissal, ultimately the member was content to retire. Before retiring, the member reached out to ACSS for help. ACSS negotiated a settlement providing this member with a significant lump sum in exchange for withdrawal of the appeal from dismissal and a release.

CCHCS member gets leave credits restored

A member at California Correctional Health Care Services (CCHCS) spent 14 months sending dozens of emails to her personnel staff attempting to get her leave credits restored. After coming to ACSS, this member's leave credits were fully restored within two weeks – just in time for them to be utilized for a planned surgery.

CDFA members reinstated through settlements

Two members at the Department of Food and Agriculture (CDFA) were served with demotions to rank-and-file positions with accompanying salary reductions of over 45 percent. The demotions would also require the members to either relocate or endure significant daily travel to new worksites. ACSS negotiated settlement agreements placing the members back into supervisory positions with much smaller salary reductions and the continued ability to telework.

As you can see from these examples, it is evident how the knowledgeable, experienced, and dedicated team of ACSS' Attorneys and LRRs work tirelessly for our members to achieve positive results. If a non-member were faced with a difficult situation like these mentioned above, the non-member would have to pay substantial attorney's fees to get issues like these resolved. While not all cases proceed to the extreme level of a full evidentiary hearing, our members are grateful to have ACSS on their side to provide representation and help resolve their workplace issues at any level.

What is Delegate Assembly?

ACSS' Triennial Event

Delegate Assembly is an important event in ACSS that occurs every three years. Its purpose is to elect appropriate leaders and improve the association by refining the way the Association functions. Preparation for this event occurs in the fall season prior to a Delegate Assembly year when Nominations for new leadership take place. In the spring of the following year, an official election of the Nominated Candidates occurs via online ballots. The result of the elections is a comprehensive body of well-qualified Delegates and Officers who have been elected by their peers to represent the members and make an impact within the organization.

Delegate Assembly is a **three-day event** that will take place in October 2024. On the first day, there is a training session for Delegates and Officers to inform them of the rules and procedures of the upcoming Assembly. There may also be ad-hock committee meetings in an informal setting to review policies and issues that may require discussion during Delegate Assembly. The first day also includes an evening meet-and-greet event for the Delegates to socialize and network.

The second day of the event is the Assembly of the Delegates. All the elected Delegates gather to discuss bylaw resolutions and other Association business. Delegates have the important task of voting on these proposed resolutions that affect the future of the



Association. Another important task of the Delegates is to vote for who will serve in the next 3-year term as Board Members.

On the last day of the event, a Board Meeting is held. This is the first meeting of the newly elected Board Members. The primary purpose of this meeting is for the Board Members to vote for the Executive Officers. These Executive Officers are Board Members who have an additional role and function at the highest level of the Association. They consist of the ACSS President, ACSS Vice President, VP of Membership Development and VP of Governmental Affairs. The Secretary/Treasurer is appointed separately.

Since 1990, ACSS has been governed by Excluded Employees just like you! It is the Members who step up to make a difference and shape the future of this organization.

This triennial event truly showcases how any ACSS member can have the opportunity to represent their fellow colleagues, take on a leadership role to help make positive changes, and participate in a 100% member-led organization.

Members may nominate themselves or others as a Delegate to serve as a representative of their Chapter at Delegate Assembly. Members may also nominate themselves or others for Chapter Officer positions during this time. Look for an Open Nominations Meeting announcement from your local Chapter in December/January.
